MAG Avionics LLC shall under no circumstances be responsible to customer or to any third party for any consequential damages as a result of the work performed by MAG Avionics LLC hereunder and the above stated indemnification of MAG Avionics LLC by customer shall apply. MAG Avionics LLC assumes no responsibility for loss or damage to aircraft or contents and components placed with MAG Avionics LLC for repair, storage or sale, from fire, theft, weather or other causes beyond MAG Avionics LLC reasonable control. Payment of this invoice is due in full when repairs are complete and prior to owner/customer taking possession of the aircraft. Owner/Customer agrees to pay in addition to all repair and maintenance charges arising hereunder, all storage fees incurred by MAG Avionics LLC as a result of the customers failure to timely pay this invoice. Owner/ Customer acknowledges and understands that until all charges incurred under this work order are paid in full to MAG Avionics LLC satisfaction they shall constitute a lien against the aircraft under the laws of the State of Texas.. This agreement shall be governed by and construed in accordance with the laws of the State of Texas. Venue shall be had in Montgomery County Texas.
